The successful candidate will be responsible for all aspects of their business and will lease the cafeteria space at the school for their operations.

Goals for the Cafeteria

- To educate and practice healthy eating habits within an educational setting
- To support the Alberta health and wellness initiative through:
 - Alberta Health Services: Healthy Eating Guidelines Alberta Nutrition Guidelines for children and youth:
 - A Childcare, School and Recreation/Community Center resource manual
- To follow the guidelines outlined by any Horizon School Division Policy
- To provide staff and students with healthy food choices available for purchase through the designated hours of operation

Operating Requirements

- Hours of Operation: 8:00 am to 1:00 pm, Monday to Thursday, or as otherwise mutually agreed, during instructional days of the school year.
- Beginning March 15, 2021 and continuing until June 25, 2020.
- Year by year lease starting on August 31, 2020 – June 29 2021 (Approximately 150 days of operation).
- The Contractor is responsible to provide the necessary equipment for operating the cafeteria.
- The Contractor will be required to acquire and maintain insurance meeting the following requirements:
 - Commercial General Liability for \$ 5,000,000 limit including Tenants legal liability,

- Property for owned contents and value of food that the operator owns,
- Include The Horizon School Division as an Additional Insured within the insurance policies,
- Request a Certificate of Insurance to evidence coverage
- Notice of Cancellation to be provided to the Board
- The contractor is responsible for all staffing requirements of the cafeteria

- Qualifications and experience of principal staff to be utilized by the Contractor
- A description of how the contractor will support the school's goals for the cafeteria
